What Does a Kidnap, Ransom, and Extortion Policy Cover?

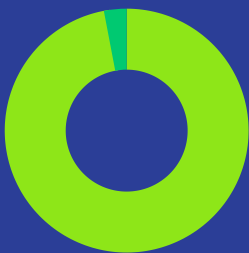
Ransom Payments and Interest

Crisis Management and Support Services

Your policy may also cover the cost of hiring additional services or consultants to assist with the ransom and negotiation process.
